



GlassMaster 30® Shingles




Tough-Glass 20® Shingles



Pro-Cut® Hip & Ridge




Pro-Cut® Starter Strip



DETAIL A COURSE LAYOUT



DETAIL B FASTENING PATTERN










FASTENING PATTERN FOR PRO-CUT® STARTER STRIP
